The institute-GCoEJ is keen to implement NEP 2020 from the academic year 2023-24. The necessary changes in the curricula and structure has been in place through various boards of studies, examination reforms, academic council etc. The NEP 2020 seeks to transform professional education by focusing on skill- based education to meet needs of the industry and the economy. To improve the skills of graduates (including multiple exit options with UG certificate, UG diploma, UG advanced diploma/B.Voc etc), learners are required to get sustainable knowledge and practical approach. Towards this, the GoM/BoG has taken a new initiative to bring leadership with professional expertise into the institutions through a position of "Principal" for a term of five years. This will help to take practices and experiences into the class rooms, administration to achieve institute goals, academic, teaching-learning, research etc betterness in all respects and also augment the faculty resource in higher education institution.

### FUTURE PLANS OF THIS INSTITUTE

- To Establish Central Facility: At present, industrial growth is satisfactory in the North Maharashtra region and in future it will be accelerated. Therefore, there is considerable scope for testing and consultancy to the nearby industries. Therefore, it is planned to establish a central instrumentation facility with all latest and hi-tech equipment to fulfill the requirement of nearby industries in respect of testing, calibration, consultancy, research, etc.
- Enhance Girls' Hostel Capacity: This institute has one girls' hostel with 106 intake and one minority girls hostel of 100 capacity. Female students from all over Maharashtra are preferring admission to this institute as it is one of the security enriched campus in the region of GoM plus it is an autonomous institute. The admission offered in this institute are on the state level merit. Therefore, there is demand for girls' hostels in the campus. At present the State Government had accorded approval for the construction of girls' hostel

for girls students with an additional 100 intake capacity. Civil work of this hostel is nearly completed and it will be handed over by PWD to this institute in near future.

- Construction of New Academic Building: Existing academic and administrative building admeasuring 9300 square meter and it is just sufficient for six UG and one PG programme. This institute has future plans to start a new UG / PG programme, post graduate courses under autonomy and research programmes, additional space will be required for the expansion of the institute. Therefore, it is planned to build an additional academic and administrative building.
- Construction of Auditorium for 1000 Students Capacity: At present, this institute has only an auditorium of capacity around 275 audiences. Considering the present/future intake of this institute, it is essential to build a state of the art auditorium. Therefore, this institute has planned to construct an auditorium with a capacity of around 1000 students.
- New Canteen Building: At present the canteen area is small though a large open space is available for use adjoining the canteen. To enrich the canteen facility for students for 24 hours, it is planned to construct a new canteen building in the open space available in the campus.
- To Improve In-campus Placement and Start-up: In campus placement scenario of this institute is satisfactory, but start-up initiatives need to be improved, slowly with its space needs to be improved. Institute is striving hard to improve in start-up by providing various types of skills and other technical training to students from second year onwards. Institute has planned to get accredited by some of the reputed industries so that there will be regular motivations from these companies. In addition to this, it is planned to establish an entrepreneurship development cell to inculcate the entrepreneurial skills among the student community.
